

Mater Prize Home VIP Upgrade Promotion

Terms and conditions (Terms)

Promotion Period

1. The "VIP Upgrade Promotion Draw" ("Promotion") commences at 12:00am (AEST) on Tuesday 23 October 2018 and closes at 11:59pm (AEST) Friday 23 November 2018. One prize draw will be conducted as part of this Promotion.

Entry and Eligibility
